If you are interested in joining the Ridley Township Swim Club please fill out a membership application and mail it to me at the above address. The following information should answer any questions you may have about the cost and procedures for admitting new members to our pool.

To join the swim club, you must purchase a bond for \$300.00. This is a one-time fee and makes you an owner of the pool. In the future, when, for whatever reason, you decide to give up your membership to the club and your bond is fully paid for, you will receive a \$250.00 refund when your bond is sold; this may take a year or two. You may purchase a bond by choosing one of the options listed below:

OPTION 1 – Payment of \$300 in full (This can be \$100 in June, \$100 in July and \$100 in August)

OPTION 2 – Payment of \$150 each year for 2 years

OPTION 3 - Payment of \$100 each year for 3 years

OPTION 4 – 1ST Year Trial Membership – No Bond for the first year – You MUST become bonded the 2nd year by using one of the first three options stated above. There are no guarantees there are open bonds available, they are available on a first come basis.

The following are the fees for the 2015 season:

<i>(This includes husband & wife or single head of household)</i>	
<i>Sinking/Maintenance Fee</i>	<i>\$100</i>
<i>Additional immediate family members <u>living within the same home</u></i>	
<i>1 year of age to 21 years of age</i>	<i>\$50 each</i>
<i>Additional Member not residing within the home or over the age of 21</i>	<i>\$150 each</i>
